ASSIGNING SOLICITORS

- When would you assign a solicitor?
- Staff members need to track constituent activity.
- Staff members need to personally cultivate the relationship, communications, and solicitations for select constituents.

TO ASSIGN A SOLICITOR IN A GIVING SCORE QUERY

- 1. Open the Giving Score query.
- 2. Click in the **Solicitor** column.
- 3. Click the binoculars B button.
- 4. Search for the solicitor that you want to assign.
- 5. Click the solicitor and then click **Open**.

TO ASSIGN A SOLICITOR ON THE CONSTITUENT RECORD

- **1**. Open the constituent record.
- 2. Click the **Relationships** tab.
- 3. Clicked Assigned Solicitors.
- 4. Click New Assigned Solicitor.
- 5. In the **Solicitor** field, click the binoculars button.
- 6. Search for the solicitor that you want to assign.
- 7. Click the solicitor and then click **Open**.
- 8. Enter additional details as needed.
- 9. Click Save and Close.

TO ADD AN ACTION IN A GIVING SCORE QUERY

- 1. Open the Giving Score query.
- 2. Click the constituent for which you want to add the action.
- 3. Under Recent Actions, click New Action.
- 4. Enter the necessary details.
- 5. Click Save and Close.
